Mayor and City Council,

Our department is proud to deliver the 2014 Annual Report to you. This report will allow you to see the progress we have made in order to deliver better service to you and the citizens we serve. You will find pertinent information inside which will illustrate this. Some of this information includes statistical information, such as a major reduction in Part 1 Crimes reported, and another year of active DUI enforcement. You will also find new information not found in the 2013 report. This includes detailed crash information. Collecting this type of information allows us to focus on the "problem areas" and create plans to correct these areas.

This year also brought a restructuring of the department. The new administration's end goal during this restructuring was to deliver more effective and efficient service, while creating accountability here at the department. We saw a total reduction of \$68,221.02 in overtime spending. We feel this effort has been successful.

We look forward to continually improving our service delivery during 2015. We have already started to "brainstorm" on how to do this. Some of our current ideas include body cameras, a mobile application for smart phones for the public, and developing our first long term strategic plan. We will also continue to move forward to work with the other area agencies to figure out how we can collectively save money while improving service. An example of this is our continued participation in joint operations with the City of Rockford Police Department and the Winnebago County Sheriff's Department.

Finally, we would like to thank each of you for supporting our department when we have asked. I assure you that we only ask for approval of a purchase when we feel that whatever we are asking for will improve our services. We like to ask "What is the return on investment?" whenever one of these purchases are made. We feel it is a privilege to serve you and the citizens of Loves Park.



This is the most current organizational chart, for the Loves Park Police Department. The chart is updated as officers move within the department to help us serve the public.



There was a total of 582 Part I Offenses, in 2014. This is a 23.5% decrease in Part I Offenses over 2013. This highest category, at 401 offenses, is theft.

Every month, nearly 18,000 city, county, state, federal, tribal, and university law enforcement agencies report crimes brought to their attention to the Federal Bureau of Investigation. The official data on crime is compiled into what is known as the Uniform Crime Reports (UCR).

Part I crimes are broken down into two categories, violent crime and property crime. The violent crime offenses that are reported include aggravated assault, forcible rape, murder, robbery, and human trafficking. The property crimes reported are arson, burglary, theft, and motor vehicle theft.

## **Total Arrests** 1396 total arrests in 2014. These are for all criminal violations

of statute and ordinance. There was a 87.38% increase in arrests from 2014. We also went to new reporting software, so this number was extracted using a different method.

# **Total Citations**


8451 total citations and warnings issued in 2014.This is a 6.65% increase in traffic contacts from 2013. These are for all violations of traffic law.

# Total Crashes


771 total traffic crashes in 2014. These include all property damage, personal injury, and fatal crashes. There was a 10.47 % increase in crashes from 2013.



2014 Calls for Service by Day of the Week








**Crashes by Month**

Prior to joining the department, Aaron served in the United States Marine Corps. During calendar year 2014, Aaron had 27 driving under the influence arrests, as well as 99 other criminal arrests. ## Patrol Division



The Loves Park Police Department Patrol Division is comprised of 24 Officers and Sergeants. The description of a patrol officer is as follows:

A patrol officer must possess knowledge of modern law enforcement principles, procedures, techniques, equipment, and possess a working knowledge of city ordinances, federal and state statutes, department policy and procedures, rules, regulations, and court opinions with emphasis on criminal law, search, seizure, and arrest. They must also possess interpersonal, verbal, and written communications skills and exercise sound judgment in evaluating situations and in decision making.

The patrol division at the police department finished the year with more tickets and traffic stops than the previous year, while working short due to injury, training, and retirement.

## **Detective Bureau**

The Detective Bureau is responsible for the investigation of cases that go beyond what the normal patrol officer is able to complete. The detectives work cases involving misdemeanor and felony charges, as well as completing all background investigations for new hires. In addition, the detective bureau is responsible for approximately 52 registered sex offenders living in the city. ## School Resource Officer

Officer Jerry Guetschow is assigned to Harlem Middle School, through a memorandum of understanding, that was drafted between the City of Loves Park and the Harlem School District. Through this agreement, the school district reimburses 75% of his salary. Jerry patrols the halls of the school, and the school grounds, on a daily basis during the school year. In the summer he works as a special enforcement traffic unit and also takes one week of the summer to teach Youth Police Academy. Jerry was selected to the office of treasurer, on the Illinois School Resource Officers Association Board, as well as being a member of the National Association. 








## **Breakfast with Santa**



On October 16, 2014, the Loves Park Police Department launched its first ever public website, at domain name www.lovesparkpolice.org. The site was built by a local company and is maintained by the police department. Our goal was to provide information to the public and allow them to research questions and the department within two or three clicks, on the website. Through analytics research we can tell that there were 2112 visits to the website and 1442 of those were unique, or first time users. During each visit, the person looks at 2.5 pages on average. We look to continue to advance the website and reach the public in this new way. Also, this site was developed to be mobile friendly, where it will display correctly from your iPad, tablet, or smartphone.

The police department started to actively use Facebook to reach the public in a new and quick way. Information is disseminated through this page on almost a daily basis and people provide feedback by commenting on these posts. The department has solved multiple crimes through the publics assistance.







The department also launched an intranet site, which is only available from computers in which we allow access or own. The site has been nicknamed and it is also located at: lppdweb. This site was designed to be a one-stop-shop for the officers, detectives, clerical, and supervisors to find what they need throughout their shift. It houses things like our report management system, crash reporting system, directed patrols, daily bulletins, interoffice memos, policy and procedure, vehicle maintenance requests, and many other useful materials. The site regularly has new information added and can be fine-tuned to fit the officers needs.



On October 1st, 2014, we implemented a new scheduling software, at the police department. Deputy Chief McCammond had conducted a staff study, while attending Staff and Command Training through Northwestern University. He looked at multiple vendors and options before deciding on netdutyonline. This system combines multiple antiquated systems, and places everything online.
After conducting a survey of department employees, the number one requested feature was online, anywhere, and 24/7 access. The new system has all of these features plus many more.

The department has started the process of a body camera project. We are looking into a regional approach, as well as an individual approach to policy, purchase, and implementation.

Our department Tasers are currently reaching life expectancy, and are no longer supported devices. We will start the upgrade process in the near future, and replace all units.

#### **Electronic Ticketing**

We have been discussing the move to electronic ticketing. The vendor has produced a new product, which is currently in the testing phase, but should be released for demonstration soon.
